2. Consideration of Minutes - April 9, 2018

Motion to approve the Minutes of April 9, 2018 was made by Vice Chair White, and Seconded by Member Wilcox. Motion carried unanimously by voice vote.

3. Voting Methodology

Jake Johansson, City Manager, provided information and statistics regarding the number of cities with council size by population, as well as district voting vs. city-wide voting. He found that most of the larger cities had more council members.

Vice Chair White doesn't believe the time is right to change the make-up of the Council at this time. The Board agreed.

Ms. Roberts asked the Board if they would like to take a recommendation to Council regarding the change as to the City Manager's contract term. She will research the need for a Charter Amendment vs. Ordinance to make the change as recommended and will bring that to the Board in June.

The Charter Review Board has proposed an amendment to the Charter regarding the term, if any, for the city manager's contract of employment. The nature of the proposed amendment requires an ordinance of the city council complying with Section 166.031, Florida Statutes, submitting the proposed amendment to the electors in a general or special election. Section 166.021, Florida Statutes, provides that any amendment changing the charter rights of municipal employees requires the electors to approve the change by referendum. September 5, 2018 is the deadline for placement of referendum questions on the November 2018 ballot.
