The Parks & Recreation Advisory Board was called to order by Chairman Wiles at 5:15 p.m.

B. ELECTION OF OFFICERS

Chairman Wiles announced his leave from the Board and thanked everyone for the opportunity to serve.

Motion was made by Member Mills-Benat to nominate Vice Chairman Bowling for Chairman and Seconded by Member Navarra. Vice Chairman Bowling accepted the nomination. Motion carried unanimously by voice vote.

Motion was made by Member Navarra to nominate Member Ball for Vice Chairman pending his acceptance and Seconded by Member Day. Motion carried unanimously by voice vote.

C. DISCUSSION/ACTION

2. Consideration of Minutes - April 16, 2019

Motion was made by Member Cameron to approve the minutes from April 16, 2019 as presented and Seconded by Member Richard. Motion carried unanimously by voice vote.

3. Recommendation on Parks Partner

Susan Lovallo, Parks and Recreation Director, presented the application to become a parks partner from Port Orange Soccer Club. Staff recommends approval.

Bill Fredette-Huffman, applicant, explained why they broke away from Florida Elite Soccer and some of the steps they have already taken to get established independently.

Motion to accept Port Orange Soccer Club as a partner was made by Member Mills-Benat and Seconded by Member Richard.

Member Mills-Benat asked staff about Southwind's fields. Ms. Lovallo informed the Board about the work that has been done to fix the field and her desire for the soccer club to take over some of the maintenance. Member Mills-Benat asked the applicant what they are going to do for community involvement. Mr. Huffman responded they have built themselves back from the ground up and community involvement is part of their next phase.

Jack Wiles, citizen, asked the applicant about the space they will require in the future. Mr. Huffman responded they just want to get established at this point and don't have any plans of expanding quickly. Mr. Wiles also discussed the amount of money the soccer club would be making and what the City charges the parks partners and the rec programs.

Chairman Bowling also spoke to the field space and hopes the soccer club would be able to help find more field space if they need it in the future and wouldn't just rely on the City to provide it.

Member Navarra doesn't want to chase a potential partner away by chasing cost recovery numbers and then the fields don't get used.

Member Day inquired about the cost of uniforms. Mr. Huffman responded the uniforms are not included in the total fee and are \$200.

Motion carried unanimously by voice vote.

4. Dissolution of Foundation

Ms. Lovallo addressed the desire from some members to have the money donated for a foundation refunded. Member Mills-Benat asked if the money could be donated. Ms. Lovallo stated they could either offer individuals their money back or it could be donated to the Parks and Recreation scholarship.

Mr. Wiles offered to head the Foundation, if possible, as he no longer serves on the Board.

Member Cameron asked if there were any other trusts or foundations supporting the department. Ms. Lovallo responded that while Family Days does help the City the Foundation would have a narrower scope to help Parks and Rec preserve land.

Member Mills-Benat stated some of the difficulties come from putting the Foundation in someone's name and them taking all the responsibility for it as it's not a city foundation.

The Board decided to continue the item to attempt to find members for the Board.

D. PARKS & RECREATION DIRECTOR'S REPORT

Ms. Lovallo informed Chairman Bowling Parks and Rec is accepting a proclamation at Council tonight, July 16, 2019, if he would like to attend. She also spoke to the budget for next year and what Parks and Recreation needs for their projects. Everything is being redone at the Airport Road park. Ms. Lovallo informed the Board that an item is coming before Council asking to rename the boat ramps at Causeway Park after Senior Deputy Frank Scofield. Rec Rangers has been very successful with about 50 kids coming to the last event. Ms. Lovallo thanked Mr. Wiles for his time served on the Board and the help he has provided over the years.

E. PUBLIC COMMENTS

Robert Reinhausen, citizen, believes the cost of uniforms and what the kids pay shouldn't be part of the discussion.

F. BOARD COMMENTS

Member Cameron asked for an updated on how the Mayors golf tournament went. Ms. Lovallo responded it was very successful, they made just under \$5,000 and that goes into the scholarship program.

The Board thanked Mr. Wiles for his service and wished him well.

Mr. Wiles thanked the Board again for allowing him to serve for so long and thanked Ms. Lovallo for all her help.
