Proposed Fee Ceiling for Golf Course

This document is for discussion purposes with the Golf Advisory board

Background:

Fees at the golf course have a ceiling set that allows the management company to adjust the rates charged to the public for services based on market, course conditions and maximizing the tee sheet. The last time these fees were adjusted or amended was in 2015. The following will outline the current and proposed maximum fee structure.

Green Fee (per person)	\$46	\$57.50

Legacy transfer fee (qualifying sale of property)	\$250	\$250.00
Cypress Pass Holder	\$2100	\$2625.00

As you can see the increases represent a 25% increase across the board. That does not mean that we will charge those rates out of the gate but that we could if the market would allow for it.

Once the golf board provides direction and has a consensus to recommend to the council an item will be prepared for the council to consider and approve.
