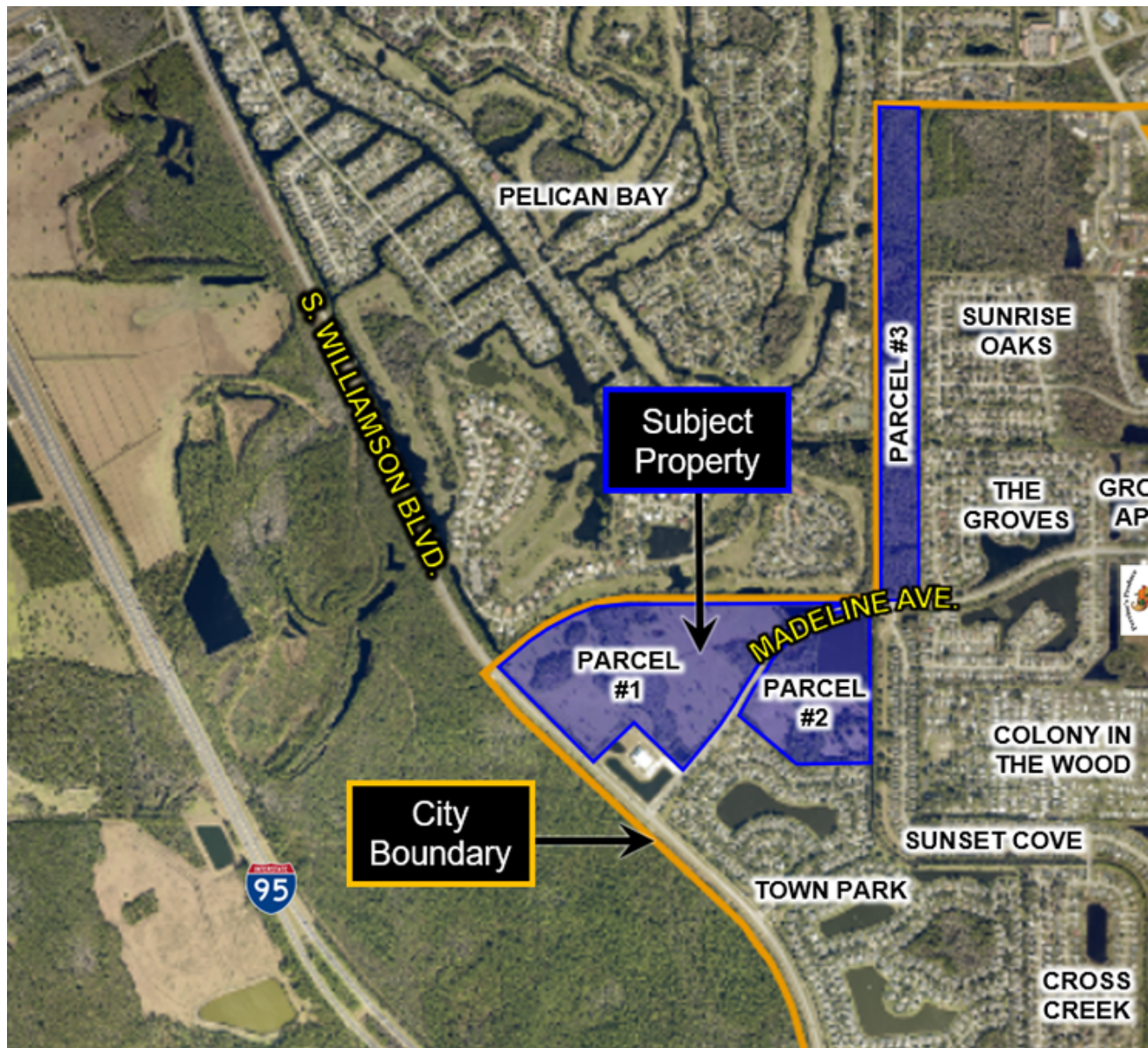

A request by the applicant to amend the Comprehensive Plan Future Land Use (FLU) Map to change the FLU designation of ±5.2 acres of Parcel 1 (Parcel 6201-00-00-0010) from Urban Medium Density Residential (4-8 units/acre) to Commercial, and to change the FLU designation of Parcel 2 (Parcel 6201-00-00-0012), consisting of ±32.4 acres, from Suburban Residential (0-2 units/acre) to ±29.9 acres of Urban Medium Density Residential (4-8 units/acre) and ±2.5 acres of Commercial, and to add a FLU Element Policy to provide density/intensity limits for the property.
